TECHNICAL ADVISORY COMMITTEE MEETING MINUTES

Monday, May 19, 2025

1. CALL TO ORDER

The meeting of the Riverside County Transportation Commission (RCTC) Technical Advisory Committee (TAC) was called to order by Chair Savat Khamphou at 10:01 a.m., in the March Field Conference Room at the County of Riverside Administrative Center, 4080 Lemon Street, Third Floor, Riverside, California, 92501 and at the teleconference site: Council Chamber Conference Room, City of Palm Desert, 73510 Fred Waring Drive, Palm Desert, California 92260.

3. APPROVAL OF MINUTES - MARCH 17, 2025

B/C/A (Walker/Mohammadi) to approve the Minutes as submitted. There were no objections to this motion.

4. PUBLIC COMMENTS

There were no public comments.

5. ELECTION OF TECHNICAL ADVISORY COMMITTEE OFFICERS

B/C/A (Khamphou/McKinney) to elect John Corella as Chair and Melissa Walker as Vice Chair.

6. FISCAL YEAR 2025/26 TRANSPORTATION DEVELOPMENT ACT ARTICLE 3 CALL FOR PROJECTS - PROJECT RECOMMENDATIONS

Edward Emery, RCTC staff, provided a presentation on the Fiscal Year 2025/26 SB 821 Call for Projects. SB 821 is a discretionary program administered by RCTC to fund local bicycle and pedestrian projects and master plans.

At its November 18, 2024, meeting, the TAC approved the updated SB 821 guidelines and evaluation criteria which were adopted by the Commission on January 8, 2025. The SB 821 Call for Projects opened on February 3, 2025, and closed on April 24, 2025. On May 15, the Evaluation Committee met to discuss and standardized scores based on the approved evaluation criteria. Upon approval, this item will be presented to the Commission for adoption on June 11, 2025.

A total of \$7.3 million is available, which for this cycle works out to a maximum of \$728,000 per project and an agency maximum of \$1.5 million.

A total of 33 applications were received, which included 19 from the Western Riverside region and 14 from the Coachella Valley region. As in previous cycles, this program came in oversubscribed with about \$19 million being requested, which is about \$12 million over the available amount. Based upon the available funding, projects scoring above 41 points are recommended for approval. Commission approved tie-breaker methodology was applied to six projects that all scored 41. As a result, 49% of total allocations will benefit the Coachella Valley and 51% of allocations will benefit Western Riverside.

The list of 13 recommended projects was shared and totaled \$7.3 million. Six of the projects are located in the Coachella Valley and seven are located in Western Riverside. The list was also included in the agenda packet.

Staff will monitor mid-year LTF revenues in January 2026 to determine if more funding is available to fund additional projects that are on the contingency list. In the event an awarded agency receives other grant funding to fully fund an approved project, or cannot deliver the funded project within the allotted time, contingency list projects will be funded in the order they are listed and will remain active until the next Call for Projects.

B/C/A (Corella/Khamphou) to approve the funding recommendations in Attachment 1 for Fiscal Year 2025/26 Transportation Development Act, Article 3, Bicycle and Pedestrian Facilities (SB 821) program funds. There were no objections to this motion.

7. CALTRANS DISTRICT 8 LOCAL ASSISTANCE UPDATE

Quyen Sy, Caltrans, provided a presentation on updates for Caltrans Local Assistance. The Call for Projects for FTA and CMAQ are due June 10, 2025. Caltrans would like to remind everyone of the importance of accuracy in programming funds, especially as it relates to non-rural allocations. The funding year and type need to be clearly identified on the application. The programmed amount should not exceed 20% of the allocated amount for Fiscal Year 2025/26.

There will be free training for the Road Safety Champion Program, which will include three modules. The first module is on May 20, Introduction to Road Safety. Module 2 will be Anatomy of a Crash: Understanding Human Factors on May 21. Module 3 will be May 22, Introduction to Traffic Safety Closure.

Coming up there will be a Federal Aid Series regarding right of way. The training date is May 21-22, 2025, from 8:30 am - 12 pm. The course objectives include overall understanding of right of way and federal-aid project regulation requirements, the utilities process, and methods to accomplish right of way deliverables.

All agencies need to submit their ASA Section 504 Program Assessments online. Reminders have already been sent out. This needs to be completed every two years, on odd numbered years. The due date is June 30, 2025.

There is a webinar coming up on Making Rural Roads Safe for All on May 14. The link to register is on the Local Assistance Blog.

Exhibit 13E, the Preliminary Right of Way Checklist, has a survey that was sent out asking for input. The responses will help Caltrans improve their processes and procedures.

Inactive projects are those that have not been billed for six months. If it has been more than six months since a project was invoiced, a reminder will be sent out to the agency.

8. CALIFORNIA TRANSPORTATION COMMISSION MEETING HIGHLIGHTS: MARCH AND MAY 2025

Jillian Guizado, RCTC staff, shared that the CTC has met twice since the last TAC meeting in March. Congratulations were given to the City of Riverside for the Local Transportation Climate Adaptation Program award for the 14th Street Pump Station planning.

Staff have been keeping the TAC informed of Climate Action Plan for Transportation Infrastructure (CAPTI) 2.0 developments, the State's update and plan to invest \$5 billion in transportation funding for projects that reduce Vehicle Miles Traveled (VMT), improve air quality, and encourage mode-shift. At the March meeting, the CTC, unfortunately, unanimously adopted a resolution to do its part in implementing CAPTI 2.0 through its programs. So, it should be anticipated that it will be even harder for Riverside County to get its fair share of gas tax funding via competitive grants moving forward.

On a brighter note, the CTC approved programming \$14 million of Local Partnership Program formulaic funds on the I-10 Monroe Street Interchange Project in Indio and \$18 million on RCTC's Mid County Parkway Contract 3 Project. RCTC's Metrolink Perris Valley Line Capacity Improvement Project moved forward with allocating \$22 million of Transit and Intercity Rail Capital Program funds for the construction phase. Lake Elsinore, Riverside County, Jurupa Valley, and Desert Hot Springs allocated Active Transportation Program (ATP) funds. CVAG, Calimesa, Moreno Valley, and Riverside were all granted time extensions on various projects.

The CTC will meet again in June in Sacramento.

9. RCTC COMMISSION MEETING HIGHLIGHTS: MARCH, APRIL, AND MAY 2025

Jillian Guizado, RCTC staff, shared that RCTC entered into a cooperative agreement with Beaumont for RCTC to lead the project initiation document (PID) phase of the SR-79 Interchange Project.

A number of agreements were approved to continue to move forward with the SR-60/Potrero Boulevard Interchange Project. RCTC is leading the project on behalf of Beaumont. The project is anticipated to be advertised for the construction phase in the next couple of months.

RCTC's Capital Team led an effort to develop a contract with Replica, a firm that provides software as a service. At a future TAC meeting, staff would like to give a presentation about how each agency can utilize the platform. The licensing fee that RCTC is paying does cover all local agencies. Hopefully, this will be something that TAC members can take advantage of.

After much debate and consternation, the Commission approved a contract that will proceed with removing the remaining call boxes in Riverside County. The removal is an action the Commission agreed to a number of years ago.

Finally, the public hearing for RCTC's budget is now open and will close on June 11. The proposed budget is \$1.4 billion for Fiscal Year 2025/26.

The next Commission meeting will be held on June 11.

Savat Khamphou, Corona, shared that after attending the Budget Hearing, it was clear that it was a great budget, much like every year, and it was almost as though the Commissioners were looking for something to comment on. The efforts of RCTC staff in managing the multi-millions of dollars in the budget are greatly appreciated.

10. COMMITTEE MEMBER / STAFF REPORT

John Corella, Cathedral City, wanted to know if anyone else's local legislators or Congressional members have reached out about working with them to fill the bucket of the surface transportation bill they are trying to get reauthorized. If you have been contacted, please note there is a deadline of May 28 to complete submissions. This would not be the competitive part, so it is important to work together and throw in all the projects that may be eligible from each agency. Something should come from it if the bill is reauthorized. This is not an earmark request, it is a request from the Senate and Congress to get the surface transportation bill reauthorized, but they need a bucket of projects to put in there.

Jillian Guizado, RCTC staff, asked that the Deputy Executive Director expand on this.

David Knudsen, RCTC staff, added that Congress is in the throes of reauthorizing the surface transportation programs, following on the heels of the Infrastructure Investment and Jobs Act (IIJA) that passed years ago which included the re-authorization of surface transportation programs. Right now, the Senate and Congressional members are looking for programmatic language, policies, and projects they can use to build the legislation. Most importantly, we want to make sure that projects in Riverside County that are eligible for federal funding, competitive or non-competitive, fit into the sequence of the policies. RCTC has submitted several policy proposals to be included in the Congressional bill. RCTC is also meeting with Congressional staff to pursue them. The intent is to make sure that the competitive dollars would be eligible for Riverside County projects. While RCTC is participating in these requests, if a member agency is contacted separately, they should respond to make sure our voices are heard.

John Corella wanted to know if RCTC was able to share the language they would be submitting.

David Knudsen noted that the language would be in the June staff report for the Legislative Update and would be published with the agenda.

John Corella congratulated Savat Khamphou for completing the mission in leading the TAC through thick and thin.

Jillian Guizado presented Savat Khamphou with a certificate on behalf of RCTC staff and the TAC, thanking Savat for his service.

11. ADJOURNMENT

There being no further business for consideration by the Technical Advisory Committee, the meeting adjourned at approximately 10:28 a.m. The next meeting will be on July 21, 2025, at 10:00 a.m.

STAFF RECOMMENDATION:

This item is to receive and file an update from Southern California Association of Governments (SCAG).

BACKGROUND INFORMATION:

In developing Connect SoCal 2024, SCAG identified a regionwide baseline network of mobility hubs, which were defined as places of connectivity where different transportation modes seamlessly converge. Such mobility hubs may include transit/rail, active transportation, and shared mobility services, and they should aim to provide better access to destinations using travel modes other than single occupant vehicles. Mobility hubs are a critical strategy for building a future where everyone has safe, affordable, reliable, and sustainable transportation options to access opportunities and resources necessary to thrive. Mobility hubs can also help the region respond to changes in travel patterns resulting from increases in work from home, facilitating access to multimodal options for many types of travel needs. Furthermore, mobility hubs are an important strategy for reducing Vehicle Miles Traveled (VMT) and Greenhouse Gas emissions (GHG).

In developing Connect SoCal 2024 mobility hubs strategy, SCAG established a baseline network of 346 sites across the region, categorized into six typologies: Downtown Hubs; Equity Hubs; Institutional Hubs; Urban Hubs; and Suburban/Rural Hubs. In developing these typologies, SCAG considered land use and transportation characteristics such as transit or auto oriented and current and future population and employment. SCAG prioritized different land use and transportation contexts that occurs throughout every county in the region. To support advancing the mobility hubs strategy, following the adoption of Connect SoCal 2024, SCAG initiated work on mobility hubs guidance and identifying potential partners for development of mobility hub conceptual designs.

Mobility Hub Design & Implementation Guide and Conceptual Designs

Through the fall and winter of 2024, SCAG developed the Mobility Hub Design and Implementation Guide. SCAG considered existing mobility hub guidance and initiatives and sought feedback from local practitioners. SCAG also considered comparable guidance developed in other regions and states. The Mobility Hub Design and Implementation Guide highlights best practices and approaches for implementing mobility hubs based on the mobility hub typologies.

The guide is divided into three sections: Plan Your Mobility Hub Network; Design the Hub; and Implement the Hub. The guide directly addresses topics such as design considerations and approaches, funding sources and costs associated with amenities, and partnership opportunities. To inspire practitioners, the guide contains case studies and visuals of mobility hub components (e.g., bike lockers, microtransit, etc.), and conceptual designs for four mobility hubs from across the region, specifically, Burbank, Fontana, Moorpark, and Perris. These four sites were part of SCAG's baseline regional mobility hub network, were prioritized to receive conceptual designs based on potential for increasing transit ridership and reducing VMT and GHG. The conceptual designs are meant to serve as model templates, with designs focused on the characteristics of the surrounding areas and multimodal integration. SCAG plans to advance up to two of the conceptual designs to implementation through SCAG's Regional Pilot Initiatives, a new incubator for pilot projects with regional scale.

Stakeholder Engagement

To ensure the guide would have practical applications throughout the region, SCAG solicited input from a broad range of stakeholders, including Caltrans and county transportation commissions. SCAG hosted a Mobility Hub Workshop, which was attended by more than 70 people, including representatives from cities, transit agencies, public higher education, nonprofits and community-based organizations, and potential private partners. Based on feedback from participants, SCAG revised the draft guide to include language around safety and security considerations for mobility hub designs. SCAG also revised the guide to enhance discussion around placemaking and curb space management along with considerations for designing mobility hubs to serve caregiving trips and the selection of amenities in space-constrained locations. The Guide and a factsheet are available on the SCAG website. A recording from the March 18, Toolbox Tuesday training session is also available.

Next Steps

SCAG began developing its Regional Pilot Initiative (RPI) mobility hub program area, where 1 or 2 of mobility hub conceptual designs may be advanced to implementation. RPI was conceived to be an incubator for pilot projects with regional scale and can be used to inform future Calls for Projects and funding opportunities. The initiative was originally part of SCAG's Regional Early Action Planning Grants of 2021 (REAP 2.0) and now funded through the Carbon Reduction Program (CRP).




Table 16: Mobility Hub Suitability Score Categories

Mobility Hub Suitability	Mobility Hub Suitability Score	Description
Optimal	75 – 100	Locations with exceptional suitability for mobility hubs, offering the highest potential for success. These areas have strong transit networks, well-integrated bike facilities, and a built environment and land use pattern that supports sustainable transportation options.
High	50 – 74	Areas with strong potential for mobility hubs, where the built environment and land use are conducive to multimodal transportation. These locations have good transit access, bike connectivity, housing and/or employment densities that support transit use.
Moderate	25 – 49	Locations with moderate suitability for mobility hubs. These areas may have some transit and bike network access but require further infrastructure improvements or increased housing and employment densities to better support mobility hub operations.
Low	0 - 24	Areas with limited current suitability for mobility hubs. These locations may have lower transit access and densities and could benefit from further infrastructure development to better support future mobility hub operations.

The mobility hub suitability score is just one factor to consider when selecting a neighborhood for a mobility hub. Chapter 5 introduces a prioritization methodology that combines the suitability score with other environmental and socioeconomic factors to evaluate and prioritize potential sites for the upcoming demonstration project. This methodology can also be applied to projects beyond the planned demonstration project.

STAFF RECOMMENDATION:

This item is to receive and file an update on Riverside County's Obligation Delivery Plan.

BACKGROUND INFORMATION:

Southern California Association of Governments (SCAG) is the Metropolitan Planning Organization (MPO) for Southern California and is responsible for ensuring that federal Carbon Reduction Program (CRP), Congestion Mitigation and Air Quality (CMAQ), and Surface Transportation Block Grant (STBG) funds apportioned to Riverside County agencies are allocated and obligated in a timely manner to prevent funds from lapsing. Federal Obligation Authority (OA) for the region is provided on an annual basis and must be used in the Federal Fiscal Year (FFY) it is provided. The Commission's goal is to help ensure that 100 percent of the OA in Riverside County is obligated.

Commission staff work closely with local agencies and the California Department of Transportation (Caltrans) to ensure projects on the Obligation Delivery Plan are obligated and delivered. Many of these projects are from the SCAG CMAQ/STBG Call for Projects, Coachella Valley Association of Governments' CMAQ Call for Projects, various individual funding commitments made by the Commission, and federal Community Project Funding/Congressionally Directed Spending (CPFCDS) (otherwise known as earmarks) awarded through Congress. The attached Obligation Delivery Plan provides an outline of the projects that have CMAQ, CRP, STBG, and federal earmarks programmed in FFY 25/26 and beyond. The information comes from milestone updates provided by local agencies, discussions with project sponsors, and monthly meetings Commission staff has with Caltrans Local Assistance.

It is recommended local agencies begin the federal-aid process as soon as possible and/or devote the resources needed to secure federal approvals for obligation to ensure timely obligation of federal funds. If a local agency anticipates a delay in obligating these funds this year, Commission staff should be provided with the new schedule as soon as possible.

Staff are available to assist local agencies with processing Request for Authorization (RFA) submittals and the overall federal-aid process.

STAFF RECOMMENDATION:

This item is to receive and file an update from Caltrans District 8 Local Assistance.

BACKGROUND INFORMATION:

Caltrans' Local Assistance Program oversees more than one billion dollars annually available to over 600 cities, counties, and regional agencies for the purpose of improving their transportation infrastructure or providing transportation services. This funding comes from various federal and state programs specifically designated to assist the transportation needs of local agencies. Annually, over 1,200 new projects are authorized through the Local Assistance Program of which approximately 700 are construction projects.

Caltrans District 8 Local Assistance is responsible for processing local agency obligations and allocations of federal and state funds, providing guidance on federal and state regulations, and direction on processes and procedures that are tied to each funding program. Local Assistance is responsible for the current funding programs as identified in Table 1.

Regarding Contracts:

Executed Contracts signed before October 3:

- Existing contracts remain valid.
- No compliance monitoring is required.
- DBE commitments and participation under existing contracts cannot be counted toward goal attainment during suspension period.
- Good faith effort documentation is no longer required for termination and replacement.

Contracts at Bid Solicitation and Procurement

- Bid solicitation and procurement must not include a DBE goal, and contracts will not follow DBE program requirements. Subsequently, Good Faith Efforts are no longer required.
- Currently advertised projects require an addendum removing the DBE goal and requirements from the bid package. The addendum may extend the bid opening period, if necessary, for bid adjustments.

Contracts at Bid Evaluation and Selection

- Projects at the bid selection stage are the most difficult. Re-advertisement is an option. Another option is selecting the lowest most qualified bidder without regard to DBE commitment.
- Caltrans recommends all agencies consult with their legal team to determine how to proceed in these situations.

Prevailing wage, certified payroll, or prompt payment, termination/replacement continue as they are upheld by other subcontractor regulations.

Caltrans Office Bulletin #25-06: Buy America Requirements for Manufactured Products

On January 14, 2025, the Federal Highway Administration (FHWA) issued its final rule amending Buy America regulations, terminating the general applicability waiver for manufactured products. These changes require updates to the Local Assistance Procedures Manual (<u>LAPM</u>) chapters 12 and 16 to ensure compliance with new Federal Requirements for Federal-Aid Highway projects. Access FHWA's final rule on <u>Buy America requirements for manufactured products</u>.

Effective **October 1, 2025**, federal-aid projects with Construction E-76 Authorizations will need to ensure all manufactured products must have been assembled in the United States that will be incorporated into the project.
