### **RCTC Receives Funding for Coachella Valley Special Event Train New train platform in Indio may lead to train service to festivals by 2020**

In a move that should be music to the ears of Coachella and Stagecoach festival attendees next year, the California State Transportation Agency awarded \$5.9 million to the Riverside County Transportation Commission (RCTC) to construct a temporary train station platform in Indio, paving the way for special event trains as early as next year.

RCTC competed for the grant through the State Rail Assistance program funded by the gas tax and is contributing an additional \$2.7 million to build the \$8.6 million project. The funding will build a temporary train platform at the City of Indio Transit Center, along with improved pedestrian access to Amtrak rail service that operates on adjacent to the tracks.

RCTC and the Los Angeles-San Diego-San Luis Obispo Rail Corridor Agency (LOSSAN) have requested access to run special Amtrak trains to the music festivals. Concert-goers would board the Amtrak train at Los Angeles Union Station to travel to the Indio Transit Center, then ride a connecting shuttle to the festival grounds.

LOSSAN Vice Chair and RCTC Immediate Past Chair Dana Reed credited the late Cathedral City Councilmember Greg Pettis for bringing the service to the area.

“Today’s historic funding announcement would not have happened without the relentless advocacy of Greg Pettis,” Reed said. “For decades, Greg walked the halls of Sacramento, Washington, DC, and every corner of the Coachella Valley to rally support for bringing rail

service to our communities. He got us to this junction and we will continue full steam ahead for him and for the people of the Coachella Valley.”

With funding on the way, RCTC will begin coordinating the construction schedule and design details for the 900-foot station platform, trackwork, drainage and pedestrian access. Construction could begin late this year.

“Finally, we are seeing our train to the Coachella Valley become a reality,” said Jan Harnik, second vice chair of RCTC. “Our world class region deserves to be accessible by rail, and I am thrilled that today our vision is moving down the tracks.”

The special event trains will provide a great opportunity while efforts continue for development of a long-term San Geronimo-Coachella Valley Rail Corridor Service. Environmental and engineering studies are under way now for this project, which proposes two daily round-trips using Amtrak service between Los Angeles and Indio.
