### Week of March 27, 2023

Nightly closures of lanes, ramps, and connectors on the 71 and 91 are planned for crews to safely continue work in the center median and continue roadway excavation and earthwork.

With rain in the forecast, please watch for possible closure postponements. Construction is subject to change.
