# **CONSTRUCTION UPDATE**

## Week of May 22, 2023

Nightly closures of lanes and ramps on the 91 and 71 in Corona are planned for crews to safely continue roadway excavation, perform earthwork, and safely move equipment into the center medians.

Due to the Memorial Day Holiday, no closures will be implemented from Friday, May 26 to Tuesday, May 30.



#### **Eastbound 91 Full Closure**

A full nighttime closure of eastbound 91 is scheduled tomorrow morning, May 20, from 1 a.m. to 6 a.m., to allow crews to safety move equipment into the center median of the 91. See the table below for additional closure details and detour route.
