

# **Program Overview**

- ✓ Measure A  $\frac{1}{2}$  cent sales tax approved by Riverside County voters
  - ✓ About 12% to Public Transit in Western Riverside County
  - ✓ Funds shall not supplant any other type of funding already in use for the proposed purpose
  - ✓ Develop sustainable projects that leverage other revenue sources, thus not requiring long-term support from Measure A funding
- ✓ Specialized Transit Call for Projects every 3 years
  - ✓ Provide services to target population: seniors, persons with disabilities, lowincome populations, or those that are "truly needy" that cannot be served on the existing transportation network
  - $\checkmark$  Focus on the provision of trips that can address service gaps

- February 14, 2024Commission Approval of Guidelines and Release of Call for<br/>Projects
- March 14, 2024 Applications due to RCTC
- April 22, 2024Award Recommendations to Western Riverside Programs and<br/>Projects Committee

May 8, 2024 Commission Approves Award Recommendations

June 18, 2024 Awardee Technical Workshop

July 1, 2024 Start of Funding Cycle

3-year Funding Availability	\$8.76 million	\$13.127 million
Matching Funds	Operations – 34% Capital Projects – 50% Mobility Management – 50%	No Change *Applicants that are transportation-only focused may be granted a lower match minimum for operating and capital projects on a case-by-case basis.
Reimbursement	30-day payment schedule for eligible costs incurred	No Change

Eligible Applicants	Public Agencies, Human and Social Service Agencies, Tribal Governments, Private non-profit organizations	No Change
Eligible Projects	Operating, Pass Programs, Vehicle Purchases, Travel Training, Capital Lease Vehicles	Expanded capital projects, examples include needed replacements and rehabilitation.
Number of Applications	No Limit	No Change
Minimum/Maximum Grant Award	No minimum Max of 18% of the available funding	No Change
Eligible Project Costs	Max of 8% of indirect costs	No change but clarification on what can be included as indirect costs
