



# CONSTRUCTION UPDATE

Week of July 14, 2025



A full nighttime closure of southbound 71 at Butterfield Ranch Rd./Euclid Ave. in Chino and Chino Hills is scheduled on **Thursday, July 17 and Friday, July 18** for crews to safely complete rock blanket installation.

Additionally, nightly lane and ramp closures on eastbound and westbound 91, along with connector closures and lane reductions on northbound and southbound 71, are scheduled throughout the week of July 14.
