Single lane closures, connector closures, and ramp closures on eastbound 91 and southbound 71 are scheduled for the night of October 16, 2025.

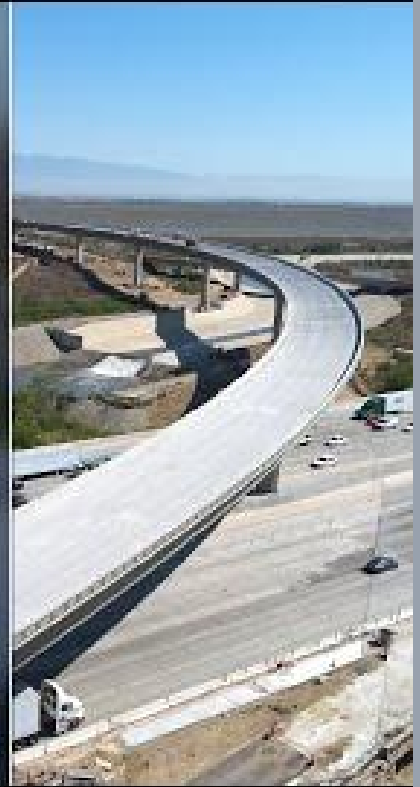
## Project Background
