




## Week of November 24, 2025

## Weeknight Full Closure of Northbound 71



A nighttime full closure of northbound 71 is scheduled for Tuesday, November 25, for crews to perform lane restriping. The eastbound and westbound 91 to northbound 71 connectors will also be closed during this time. Additional lane and connector closures are scheduled Monday, November 24, 2025.

The westbound 91 to northbound 71 merge point will be restriped and shifted further north along northbound 71. Once the connector reopens, motorists are urged to be on the lookout for the new traffic pattern.


