The individual will help shape the operational backbone of RCTC's toll enterprise, including maintaining high customer service satisfaction, system reliability, and financial performance. Reporting to the Deputy Executive Director, the Director of Toll Operations serves as a Contract Department Head and member of the Executive Management Team.

The Director provides strategic leadership and full operational oversight of RCTC's toll/express lane programs, systems, and facilities — including business operations, customer service, marketing, toll system performance and security, contract administration, and long-term financial sustainability. The position exercises broad independent judgment within legal and policy frameworks and leads management, professional, technical, and administrative staff.
